The promise of a democratic society is visible in few places more than in public schools. And yet in the United States today, the grim reality is that public education is a driver of inequality, not a weapon against it. Thanks to an education system funded overwhelmingly by local property taxes, residential segregation by class and race produces educational segregation by class and race, and vice versa. School segregation is worse now than it was 30 years ago.

#### **SOCIAL HOUSING**

Across the country, organizers and policymakers are increasingly discussing the construction of new social housing as an important part of the solution to the crisis of affordable housing facing working people in so many places. Enacting tenant protections and preserving the affordability of existing units is crucial. And, in many places, there are simply not enough homes for people who want to live and work there. New housing is healthier, climate friendly, and can encourage the use of public transit.

However, right now our policy mix for encouraging the development of new affordable housing is

offering incentives to private, profit-seeking developers. The results have been disappointing. Social housing refers to housing that is owned by the government and available to people of all incomes, typically containing a mix of market-rate and subsidized units. The rent collected from social housing developments helps maintain those developments and also facilitates the development of more social housing. Over time social housing can contribute to relieving the shortage of decent, affordable homes and decreasing our reliance on profit-seeking businesses to meet basic social needs.

#### **WORKERS RIGHTS, WORKER PAY, AND WORKER POWER**

Beginning with the passage of the Taft-Hartley Act in 1947, and continuing across many decades, the Federal Government has steadily narrowed the legal basis of workers' right to organize and collectively bargain. More than 40 years after the corporate class and their political allies launched an all-out war on union power, we have seen the results: stagnant wages coupled with skyrocketing CEO pay; the near-elimination of retirement security; worsening workplace safety; more states adopting "right to work"; and everywhere you look, more and

more egregious forms of exploitation.

The WFP believes that a strong labor movement is essential to the economic well-being of working people, and a bedrock of democracy. We support comprehensive and aggressive measures to shift the balance of power from bosses to workers. Right now one of WFP's top priorities is passing the Protecting the Right to Organize (PRO) Act. The PRO Act would repeal much of the anti-worker legislation that has been enacted in this country, starting with Taft-Hartley, including the ban on so-called secondary boycotts and the allowance for states to enact Right to Work laws that allow free-riding at unionized employers. PRO would levy strict penalties on employers for violations of workers' organizing rights, and would ban a number of anti-union practices that employers have perfected in recent decades, especially so-called captive audience meetings. It would protect the right to strike, and impose mandatory first contract arbitration so that employers can't undermine successful organizing efforts by dragging out negotiations.

#### **IMMIGRATION AND CITIZENSHIP**

Across the country, people were horrified by the Trump administration's deliberate cruelty towards people seeking to come to this country, his racist demonization of them, his family separation policies, his evisceration of the right to asylum, and his determination to build a literal wall to prevent people from coming into this country. We also know that, before Donald Trump, and previous Democratic administrations used aggressive enforcement to try to win conservative support for immigration reform, with nothing to show for it except staggering numbers of deportations. In his first days as President, Joe Biden took encouraging steps to reverse some of the worst Trump-era policies. But deportations are continuing, and detentions are increasing. Since the failure to include immigration reform in a reconciliation bill while Democrats controlled both chambers of Congress, the President has opened up some new pathways to citizenship, but he has also extended Title 42 (a Trump-era policy that denies people the right to seek asylum and forces them instead into dangerous camps), and DREAMers remain in limbo.

We believe we must begin shifting resources away from policing, jails and detention centers, and other agencies that separate families and invest those resources into schools, housing, healthcare and jobs, to enable all people – especially Black and brown people, immigrants, and Indigenous people – to be safe and to thrive.
